## **Update on SJ response**

We are starting to get info back from Sustainable Jersey on what is approved or not. So far, we have definitely made Bronze with 270 points! There are 3 categories - approved (we get the points), must revise (we need to revisit it to get the points), and submitted (hasn't been judged yet).

Please note that SJ has now completed judging our submissions! Innovative Community Project 1 - ERI Quilts and Community Forestry Plan & Tree Cover Goal have passed and we are just 80 points away now from Silver. This means we need to get at least 8 of the Must Revise list to pass.

#### SJ Actions for 2017 -

We are working on other longer term actions that will be for the 2017 submission to SJ. Unfortunately, SJ is not offering grants right now so we need to look into other grant sources for the recycling roof and the iTree funding.

The assessment of the schools for energy conservation solutions will go into effect next year which is too late for this cycle but should be fine for 2017.

Mimi suggests getting the design and build class in the high school to design solutions for the recycling cover. Joan can supply them with a video of how the trucks move and dump the recycling into the bins.
